2020 was a year none of us expected. While it was a year of unparalleled challenges, 2020 brought tremendous opportunities for our profession. I am so proud to have served as President of the Colorado Pharmacists Society and watched pharmacists across our state step up to serve our patients and citizens in countless ways.

From the moment the pandemic broke, pharmacists were on the front lines working countless hours making sure patients had access to their medications. In hospitals, pharmacists worked around the clock, often times in critical care units that were converted overnight to COVID-19 units. Pharmacists in rural communities worried about how they would provide care to their communities should they become ill or had to quarantine.

CPS provided a voice for the pharmacy profession and needed resources for patient care. Within just a couple of weeks, CPS partnered with the University of Colorado Skaggs School of Pharmacy to host numerous free webinars to pharmacists across our state on breaking news and therapies related to the coronavirus. We learned quickly how many participants a Zoom webinar can host – 500!

Through our lobbyist, Katie Wolf, CPS worked closely with the Governor's Office, the Board of Pharmacy, and the Colorado Department of Health and Environment (CDPHE) to address rules and scope of practice to allow pharmacists to practice at the top of their scope and remove regulatory barriers posed by the pandemic. Our Executive Director, Emily Zadvorny, remains involved with CDPHE to ensure pharmacists are at the front lines providing COVID immunizations once vaccines become available.

CPS remains a strong and vibrant organization through all of our members and academies. This report just provides highlights of the many accomplishments and events of this past year. Looking forward to 2021, we embrace the challenges ahead of us. Sunset of the pharmacy practice act will occur this next legislative session and we need to ensure pharmacists are reimbursed for their clinical contributions to patient care. Pharmacists have the privilege of making a difference in patient's lives and CPS continues to advocate on behalf of our profession and members.

Academy of Community Pharmacists (ACP)

ACP was founded in the fall of 2018 when over 50 community pharmacists petitioned for the Academy. During 2019-2020, ACP established quarterly meetings, provided community pharmacist perspective for various requests, submitted monthly Academy updates to the CPS Newsletter, and joined forces with other Academies to boost meeting and event attendance. The Academy also hosted a Fall Happy Hour and Networking Event in October 2019, and successfully pivoted the Mountain States Residency Conference Practice Session to a virtual event in April 2020.





Academy of New Practitioners (ANP)

ANP is open to any CPS member who considers themself to be a new practitioner. This is typically anyone who has graduated from PharmD program within the last seven years. The ANP helps new practitioners achieve personal and professional growth by providing networking and leadership opportunities. During the 2019-2020 year, ANP organized the Annual Fall Student-ANP Social and the Colorado Residency Showcase. ANP also hosted a Wellness Series, a Cover Letter Review Event, and held the second annual ANP Social at the CPS Winter Meeting.









Academy of Health-System Pharmacists (AHP)

AHP is the state-affiliate of the American Society of Health-System Pharmacists (ASHP). This Academy represents healthcare professionals who serve as patient care providers in acute and ambulatory settings, including pharmacists, student pharmacists, and pharmacy technicians. During 2019-2020, the Academy was granted ASHP Full Affiliation Status with ASHP! AHP also focused their advocacy efforts at the Capitol & Policy Week on increased competition, transparency to address rising drug cost; strengthening reporting, quality requirements to address drug shortages; and expanding pharmacists' ability to treat opioid addiction. AHP also advocated for Colorado Residency Programs by writing a letter on behalf of all Colorado Residency Programs submitted to CMS and advocating for improvements in Pharmacy Residency Program Oversight. They also attended the Colorado Residency Conference where they surveyed all program directors to gauge interest and developed a planning committee to convene in June 2020!

NEW! Academy of Clinical Specialists (ACS)

The New Academy of Clinical Specialists (ACS) was founded in 2020 with the inaugural Council of Psychiatric Pharmacists (ACS-CPP). The Academy represents pharmacists, pharmacy students or pharmacy technicians that have a clinical specialty. The CPP has a specific interest in mental health and the Council membership covers Board Certified Psychiatric Pharmacists (BCPP), outpatient specialty pharmacists, inpatient (VA and UCHealth), and academics. During 2020, the ACS-CPP established bylaws and roles and responsibilities, hosted quarterly networking events, surveyed the membership for interests and focus, and are planning several live and written educational opportunities. Other Councils can be formed in other specialized interest areas upon request.

Academy of Student Pharmacists (ASP)

ASP strives to represent all pharmacy students in the state of Colorado, regardless of college of enrollment or area of interest. Many of this Academy's events are collaborative with student organizations at both schools of pharmacy and other academies within CPS. During 2019-2020, ASP held a Back-to-School ASP/ANP Social, wrote a Letter of Intent Review with ANP volunteers at University of Colorado, held a Midyear 101 event at Regis University, and a Legislative Lunch & Learn at University of Colorado. ANP was also proud that more than twenty students from both schools attended CPS 2020 Legislative Day at the Capitol to advocate for the profession and represent the future of pharmacy!






Committee Chair: Gina Moore

During the last legislative session the Legislative Committee monitored all legislation in Colorado that impacted pharmacy. Committee meetings were held every other week to keep the members informed and gain feedback. The CPS Legislative Day at the Capitol was well attended by pharmacists and students, and attendees were provided their specific legislators names and tasked with discussing legislation important to the pharmacy profession. The Legislative Committee is also proud to report that the CPS sponsored HB20-1078 (Prohibits retroactive DIR fees) passed and and was signed by Governor Polis. CPS was also instrumental in passing HB 20-1061which allows pharmacists to prescribe and get paid for HIV PrEPand PEP services.

The Legislative Committee also conducted extensive advocacy during COVID-19, including: remote pharmacy practice; removing signature requirements to protect the health our patients and pharmacy staff; delaying technician certification/registration; connecting hospital pharmacy leaders with the FDA regarding medication shortages; pharmacist inclusion in telehealth services; and reimbursement (clinical services, added services,

deliveries)



The Membership Committee is comprised of pharmacists, students and technicians, representing community practice, health systems, academia and the pharmaceutical industry. This Committee continued to work with the Communications Committee to produce bi-monthly Member Spotlights. They also worked on two postcard campaigns to non-member pharmacists within the state of Colorado and launched CPS logo apparel to the membership in 2020. The Committee also completed two rounds of personalized emails to immediate lapsed members and revised/implemented CPS's Corporate Membership and New Graduate Membership.

From April 2019 through April 2020 this Committee noted a 13.5% growth in CPS membership. Looking across the different types of membership during this time Pharmacist members grew by 23.8% and Technician members by 75%.


Winter Meeting Continuing Education Committee - 2020
